Commissioner Rester moved to approve the following progress payments: Balch & Bingham (\$18,680.00); Digital Engineering (\$31,620.75); Ray C. Weaver Mechanical Contractors (\$2,830.18); and Southern Exteriors Fence Co. (\$11,532.65). Commissioner Knesal seconded, and the motion was unanimously approved.

Commissioner Simpson moved to approve Cash Request #301 to Eley Guild Hardy (\$56,940.80); MSPA (\$10,822.90) and Wharton Smith (\$848,100.81) for a total of \$915,864.51. Commissioner Rester seconded and the motion was unanimously approved.

Commissioner Knesal moved to approve Cash Request #302 to CH2MHill for a total of \$32,815.30. Commissioner Simpson seconded and the motion was unanimously approved.

#### **OLD BUSINESS:**

Commissioner Rester moved to award a contract to Warren Paving, Inc. for the Paving Maintenance and Repair Project. Two bids were received with Warren Paving having the lowest bid of \$3,445,240.00. Commissioner Knesal seconded and the motion was unanimously approved.

Commissioner Rester moved to authorize the execution of a Grant Agreement with MARAD. The grant amount is \$15,760,000.00 and requires a non-federal cost share match of \$3,940,000.00 for a \$19,700,000.00 total program. Commissioner Knesal seconded and the motion was unanimously approved.

#### **NEW BUSINESS:**

Commissioner Rester moved to approve Work Order No. 21 with Digital Engineering under Contract No. 17-EN-04. Work Order No. 21 has a not to exceed amount of 200,698.00 for engineering and design work needed for various and somewhat comprehensive structural, mechanical, and electrical repairs and improvements to East Pier Shed 50 and shed 50 Addition. Commissioner Simpson seconded and the motion was unanimously approved.

Commissioner Rester moved to authorize DeeDee Wood, CFO as Applicant Agent and Tammy Salisbury, Assistant Comptroller as Alternate Applicant Agent as MSPA Agents for FEMA and Hurricane Ida Disaster Assistance. Commissioner Simpson seconded and the motion was unanimously approved.

Commissioner Simpson moved to approve the First Lease Amendment between the MSPA and Hancock Whitney Bank, Landlord. The First Lease Amendment addresses the conflicting term in the original lease and confirms the 10-year term. The Amendment also changes the name of the landlord to Hancock Whitney Bank. Commissioner Rester seconded and the motion was unanimously approved.

#### **RESOLUTION NO. 21-02**

The Board of Commissioners of the Mississippi State Port Authority at Gulfport ("MSPA") took up for consideration the matter of authorizing the MSPA to exercise the right of eminent domain in accordance with Miss. Code Ann. § 59-5-39, if necessary, for the limited purpose of facilitating the acquisition of certain real property from the Mississippi Transportation Commission ("MTC") located in the City of Gulfport, Mississippi (collectively, the "Property") as more particularly described as set forth on Exhibit "A" attached hereto and fully incorporated herein by this reference. Thereupon, Commissioner \_\_\_\_\_\_\_\_\_ offered and moved the adoption of the following resolution:

RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE MSPA AUTHORIZING THE MSPA TO EXERCISE THE RIGHT OF EMINENT DOMAIN IN ACCORDANCE WITH MISS. CODE ANN. § 59-5-39 TO ACQUIRE THE MTC PROPERTY.

WHEREAS, in accordance with Miss. Code Ann. § 59-5-1, et. seq., including, without limitation, Miss. Code Ann. §§ 59-5-11 and 59-5-23, the MSPA is authorized, among other things, to acquire, purchase, own and construct bulk loading or unloading facilities, warehouses and any other facilities required or incidental to the improvement, operation, development, and expansion of the Mississippi State Port at Gulfport (the "State Port") and make advancements and developments in the transportation system to accommodate for the import and export of cargoes and other goods to and from the State Port;

WHEREAS, the MSPA currently operates at its State Port facilities and infrastructure south of U.S. Highway 90 in Gulfport, along with various parcels of land north of U.S. Highway 90 that are used by the MSPA for the advancement of the transportation of import and export cargoes and other goods;

WHEREAS, due to a change in circumstances concerning the Port Connector Project (STP-1145-00(007), 101212/203000) (the "Project"), MTC has determined that the Property will not be used for purposes of the Project but should continue to be used to benefit the public;

WHEREAS, due to the size, location and proximity of the Property to the aforementioned State Port facilities, the MSPA has determined that the Property can be acquired by the MSPA for continued public use for the advancement, promotion and development of the State Port at Gulfport;

WHEREAS, the MSPA has completed its due diligence and has received an appraisal and review appraisal of each parcel making up the Property identifying a total fair market value determination of Four Million Six Hundred Sixty-Five Thousand and No/100 Dollars (\$4,665,000.00) and the MSPA is prepared to acquire the Property from MTC for the purposes set forth herein. A copy of each appraisal and review appraisal of the parcels making up the Property is attached hereto as composite Exhibit "B" and fully incorporated herein by this reference;

WHEREAS, MTC has expressed its agreement to convey the Property to the MSPA in exchange for the recited fair market value;

WHEREAS, the MSPA is authorized by Miss. Code Ann. §59-5-39 to acquire land and property by condemnation, and should it elect to exercise the right of eminent domain, it may proceed in the manner provided by the general laws of the state of Mississippi for procedure by any county, municipality or corporation organized under the laws of the state of Mississippi, or in any other manner provided by law;

WHEREAS, pursuant to Miss. Code Ann. § 59-5-39, the MSPA's power of eminent domain applies to property already devoted to public use including leaseholds, excepting interests in property owned by levee boards, drainage districts, or other flood control agencies;

WHEREAS, consistent with the public policy set forth in Miss. Code Ann. 59-5-3, the MSPA has determined that acquisition of the Property is a public necessity for the advancement, promotion and development of the State Port given the size, location and proximity of the Property to the aforementioned State Port facilities and the need for the MSPA to continue to make advancements and developments in the transportation system to accommodate for the import and export of cargoes and other goods to and from the State Port;

WHEREAS, because this Property was initially acquired by MTC for a public use related to the Project and upon the MSPA's acquisition thereof, the Property will continue to retain its public use designation, the MSPA has determined that, should it be deemed necessary after conducting good faith negotiations, the exercise of the MSPA's eminent domain authority is a proper exercise of the MSPA's power for the limited purpose of facilitating the acquisition of the Property from MTC in exchange for fair market value;

WHEREAS, the MSPA now desires to authorize the MSPA to attempt to acquire the Property from MTC by negotiations and thereafter to exercise the right of eminent domain in accordance with Miss. Code Ann. § 59-5-39 for the limited purpose of facilitating the acquisition of the Property from MTC in exchange for fair market value and hereby authorizes the MSPA, by and through its Executive Director, to notify MTC of its intention to acquire the Property by eminent domain and proceed with any such actions, including negotiations, to facilitate the acquisition as may reasonably be necessary and in the manner provided by the general laws of the state of Mississippi, or in any other manner provided by law.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE MISSISSIPPI STATE PORT AUTHORITY AT GULFPORT, AS FOLLOWS:

The MSPA, acting by and through the Board of Commissioners, hereby determines that the MSPA's exercise of its eminent domain authority under Miss. Code Ann. § 59-5-39 is a proper exercise of the MSPA's power for the limited purpose of facilitating the acquisition of the Property from MTC in exchange for fair market value and authorizes this resolution to be submitted to the Mississippi Development Authority for its review and joint approval of the findings set forth herein.

The MSPA, acting by and through the Board of Commissioners, hereby determines that acquisition of the Property is a public necessity for the advancement, promotion and development of the State Port given the size, location and proximity of the Property to the aforementioned State Port facilities and the need for the MSPA to continue to make advancements and developments in the transportation system to accommodate for the import and export of cargoes and other goods to and from the State Port.

The Board of Commissioners further approves the determination of total fair market value of Four Million Six Hundred Sixty-Five Thousand and No/100 Dollars (\$4,665,000.00) as set forth in the appraisal and review appraisal of each parcel making up the Property.

The Board of Commissioners further authorizes the MSPA to attempt to acquire the Property from MTC by negotiations and thereafter to exercise the right of eminent domain in accordance with Miss. Code Ann. § 59-5-39 for the limited purpose of facilitating the acquisition of the Property from MTC in exchange for fair market value and hereby authorizes the MSPA, by and through its Executive Director, to notify MTC of its intention to acquire the Property by eminent domain and to proceed with any such actions, including negotiations, to facilitate the acquisition of the Property as may reasonably be necessary and in the manner provided by the general laws of the state of Mississippi, or in any other manner provided by law.
