Commissioner Knesal moved to approve the Port User Licenses, pending receipt of all fees and insurance documents. Commissioner Rester seconded and the motion was unanimously approved.

Commissioner Simpson moved to approve the following progress payments: Balch & Bingham (\$85,161.90) and Digital Engineering (\$87,382.25). Commissioner Rester seconded, and the motion was unanimously approved.

Commissioner Knesal moved to approve Cash Request #282 to CH2MHill (\$36,817.04); Eley Guild Hardy (\$48,878.75); MSPA (\$11,919.49) and Wharton Smith (\$956,977.05) for a total of \$1,054,592.33. Commissioner Rester seconded and the motion was unanimously approved.

NEW BUSINESS:

Commissioner Rester moved to approve Work Orders No. 14 and 15 under Contract No. 17-EN-04 with Digital Engineering. Both Work Orders are related to Hurricane Zeta recovery and repair efforts. Work Order No. 14 has a not to exceed amount of \$91,490.00 and Work Order No. 15 has a not to exceed amount of \$38,062.00. Commissioner Simpson seconded and the motion was unanimously approved.

Commissioner Rester moved to authorize the acceptance of the FY2021 Multi-Modal Program Grant Agreement with granted funds in the amount of \$430,000.00. This grant money will be used towards the North Harbor Drainage and Rail Access Improvements. Commissioner Norris seconded and the motion was unanimously approved.

Commissioner Rester moved to authorize the designation of Deborah Wood as MSPA's Applicant Agent for FEMA for assistance from Hurricane Zeta. Tammy Salisbury is designated the Alternate Applicant Agent. Commissioner Norris seconded and the motion was unanimously approved.

PORT RESTORATION/ENGINEERING UPDATE:

John Webb and Nick Foto gave status updates on current restoration and engineering projects.

OPERATIONS REPORT:

Shawn Meyer, Director of Operations reported on the maritime activity for the month of January 2021:

Commissioner Simpson moved to close the meeting to discuss the need for an Executive Session. Commissioner Rester seconded and the motion was unanimously approved.

Commissioner Simpson moved to enter Executive Session to discuss real estate matters (lease negotiations), legal matters (litigation) and a personnel matter. Commissioner Knesal seconded and the motion was unanimously approved.

Commissioner Rester moved to come out of Executive Session. Commissioner Norris seconded and the motion was unanimously approved.

RESOLUTION NO. 21-0|

RESOLUTION OF THE BOARD OF THE MSPA AUTHORIZING THE MSPA TO EXECUTE THE MOA WITH MTC FOR THE RIGHT TO PURCHASE CERTAIN REAL PROPERTY LOCATED IN THE CITY OF GULFPORT, MISSISSIPPI.

WHEREAS, Section 59-5-37(1) of the Mississippi Code authorizes, among other things, the MSPA to make all contracts and purchases incidental to or necessary for the advancement, promotion and development of the State Port at Gulfport;

WHEREAS, pursuant to Section 59-5-39 of the Mississippi Code, the MSPA is authorized to acquire real property by purchase for, among other things, the advancement, development and improvement of the State Port at Gulfport;

WHEREAS, in fulfillment of MTC's statutory duties and responsibilities to aid in the coordinated and efficient use of the transportation system utilized by the MSPA and to minimize the impacts to the local community in the downtown area of the City of Gulfport, MTC acquired certain parcels of real property located on various streets within the City of Gulfport, in the vicinity of the Port at Gulfport, for use in its Port Connector Project (STP-1145-00(007), 101212/203000) (the "Project");

WHEREAS, due to a change in circumstances concerning that Project, MTC has determined that certain parcels (the "Parcels") that were acquired by MTC will not be used for the Project;

WHEREAS, due to the size, location and proximity to other State Port facilities, the MSPA has determined that the Parcels can be utilized by the MSPA for the advancement, promotion and development of the State Port at Gulfport;

WHEREAS, the MSPA and MTC now desire to enter into the MOA attached hereto as Exhibit "A" and fully incorporated herein by this reference, which sets out each party's respective rights and obligations and grants to the MSPA the right to purchase the Parcels from MTC upon completion of certain due diligence and thereafter presenting an offer to purchase based upon fair market value;

WHEREAS, upon presenting an offer to purchase the Parcels, MSPA would take title to the Parcels from MTC with no warranties and without restrictions for future development;

WHEREAS, recognizing itself as a stakeholder and partner with the City of Gulfport's revitalization efforts of the downtown area, the MSPA hereby expresses its intention, to the extent reasonably practicable, to collaborate with the City of Gulfport regarding the MSPA's development of the Parcels in the manner consistent with the MSPA's statutory directive set forth in Mississippi Code §§ 59-5-1, et seq. taking into consideration, among other things, the future revitalization and buildout of the downtown area endeavoring to generate increased economic activity both at the State Port at Gulfport and the downtown area;

WHEREAS, the Board of Commissioners hereby authorizes and directs the MSPA, by and through its staff, to engage the necessary parties to conduct an appraisal and a subsequent review appraisal for a fair market value determination of the Parcels and to conduct such due diligence as is reasonable necessary to determine marketability of such title related thereto, and the Board of Commissioners hereby authorizes and directs the President of the Board to execute, complete and deliver the MOA along with all other necessary documentation to MTC and to do and perform such other acts and deeds on behalf of the MSPA as may be deemed necessary or desirable at any time or from time-to-time in connection with the matters contemplated in this Resolution; and

WHEREAS, that, any and all actions heretofore or hereafter taken by the MSPA in connection with or related to the matters set forth herein as contemplated by the foregoing Resolution be, and are hereby adopted, affirmed, approved and ratified in all respects as the act of the MSPA.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE MISSISSIPPI STATE PORT AUTHORITY AT GULFPORT, AS FOLLOWS:

The Board of Commissioners hereby authorizes and directs the MSPA, by and through its staff, to engage the necessary parties to conduct an appraisal and a subsequent review appraisal for a fair market value determination of the Parcels and to conduct such due diligence as is reasonable necessary to determine marketability of such title related thereto, and the Board of Commissioners hereby authorizes and directs the President of the Board to execute, complete and deliver the MOA along with all other necessary documentation to MTC and to do and perform such other acts and deeds on behalf of the MSPA as may be deemed necessary or desirable at any time or from time-to-time in connection with the matters contemplated in this Resolution.
