Commissioner Symmes moved to approve Cash Request #326 to Wharton Smith for a total of \$25,283.22. Commissioner Rester seconded and the motion was unanimously approved.

Commissioner Symmes moved to approve Cash Request #327 to Eley Guild Hardy (\$32,431.50); MSPA (\$10,530.87); Wharton Smith (\$1,396,547.47) and Wharton Smith (53,818.26) for a total of \$1,493,328.10. Commissioner Rester seconded and the motion was unanimously approved.

Commissioner Rester moved to approve Change Order No. 2 with DNA Underground, LLC under Contract No. 022-EN-01. Change Order No. 2 increases costs by \$33,991.10 and adds 20 days to the contract time. Commissioner Symmes seconded and the motion was unanimously approved.

Commissioner Rester moved to award the East Pier rail repair contract to Continental Rails, Inc. Two bids were received, with Continental Rails, Inc. having the lowest and best bid at \$395,997.00. Commissioner Symmes seconded and the motion was unanimously approved.

Commissioner Rester moved to approve a Professional Service Agreement with Machado-Patano, PLLC dba MP Design Group for consulting and engineering services. The term of the Agreement will be three years with a renewal option of one year. Commissioner Simpson seconded and the motion was unanimously approved.

NEW BUSINESS:

Commissioner Simpson moved to approve the Fiscal Year 2024 LBO Budget in the amount of \$76,730,151.00. Commissioner Rester seconded and the motion was unanimously approved.

Commissioner Rester moved to approve Resolutions No. 22-01 and 22-02. Resolution 22-01 authorizes application to the Gulf Coast Restoration Fund Grant for a \$2.5 million project for the planning and design of a cold storage facility. Resolution 22-02 authorizes the allocation and expenditure of MSPA's required match of 20% funding with the grant. Commissioner Symmes seconded and the motion was unanimously approved.

PORT RESTORATION/ENGINEERING UPDATE:

Port Engineer, James Buras, updated Commissioners on ongoing engineering projects.

The National Wildlife & Fisheries Grant that was previously approved in August of 2021, was awarded but declined by the MS State Port Authority due to timing and rising costs.

OPERATIONS REPORT:

Shawn Meyer, Director of Operations, reported on the maritime activity for June 2022:

TEU's were up by 7% over last year the tonnage count was up by 15%. From this same time last year, imports are up slightly, exports up significantly and bulk cargo is up as well.

Port staff were in Jackson a couple of weeks ago at a lumber conference, sponsored by the Mississippi Department of Agriculture. Many good contacts were made and we identified a number of lumber exporters that are interested in using our port. While there, we met again with Taylor Machines and look forward to co-marketing with them for future business.

We will host Secretary of State Michael Watson on Monday for a port tour and have recently heard from Lt. Governor Delbert Hosemann, who offered his support.

RESOLUTION NO. 22-01

After proper notice, a quorum of the Board of Commissioners ("Board") of the Mississippi State Port Authority at Gulfport ("MSPA") took up for consideration the matter of authorizing the MSPA to pursue and apply for certain grant funds, including, without limitation, the Mississippi Gulf Coast Restoration Funds Grant Program (collectively, the "Grant Funds"), for the purpose of making certain improvements of facilities at the State Port. Commissioner moved for the adoption of the following resolution:

RESOLUTION OF THE BOARD OF THE MSPA AUTHORIZING THE MSPA TO PURSUE AND APPLY FOR GRANT FUNDS, INCLUDING, WITHOUT LIMITATION, MISSISSIPPI GULF COAST RESTORATION FUNDS, WHICH WILL BE USED FOR CERTAIN IMPROVEMENTS AT THE STATE PORT.

WHEREAS, Section 59-5-37(1) of the Mississippi Code authorizes, among other things, the MSPA to make all contracts and purchases incidental to or necessary for the advancement, promotion and development of the State Port;

WHEREAS, in a manner consistent with the authority granted under Section 59-5-37(1) of the Mississippi Code, the MSPA is eligible to pursue and apply for certain grant funds that will be used for the advancement, development and improvement of facilities at the State Port;

WHEREAS, the MSPA has identified the use of grant funds for certain improvements at the State Port, including, without limitation, the planning and preliminary design of a cold storage and blast freezer facility and a study to determine: (1) the most advantageous location for such a facility, and (2) the utility upgrades that would be necessary for such a facility;

WHEREAS, these expanded operations will create additional sources of revenue for the State Port and the increased capacity for such operations will stimulate economic growth and development at the State Port and throughout the Mississippi Gulf Coast region;

WHEREAS, the Board of Commissioners of the MSPA hereby authorizes the MSPA to pursue and apply for certain grant funds that the MSPA is eligible to receive for the purpose of advancing, promoting and developing the State Port, including, without limitation, pursuing all those grant opportunities that support projects that will impact the competitiveness of State Port and have the potential to generate increased economic activity at the State Port and throughout the Mississippi Gulf Coast region;

WHEREAS, on September 5, 2018, Governor Phil Bryant signed Senate Bill 2002 into law, establishing the Gulf Coast Restoration Fund (the "GCRF"), which is codified at Section 57-119-1, et seq. of the Mississippi Code;

WHEREAS, under the GCRF, grant funds shall be used for programs and projects that have the potential to generate increased economic activity in the Gulf Coast region and applicants eligible for assistance under the GCRF include, without limitation, local units of government, nongovernmental organizations, institutions of higher learning, community

airports, public-private partnerships, private for-profit entities, private nonprofit entities and local economic development entities;

WHEREAS, the Board of Commissioners hereby authorizes and directs the MSPA, by and through its Executive Director and/or his designee, to pursue and apply for certain Grant Funds that the MSPA is eligible to receive, including, without limitation, GCRF Funds, and to execute, complete and deliver all necessary documentation, applications and other instruments to the appropriate authority administering such grant(s), as may be required at any time and from timeto-time, based upon each Grant's requirements and to do and perform such other acts and deeds on behalf of the MSPA as may be deemed necessary or desirable at any time or from time-to-time in connection with the matters contemplated in this Resolution; and

WHEREAS, that, any and all actions heretofore or hereafter taken by the Executive Director and/or his designee in the name and on behalf of the MSPA in connection with or related to the matters set forth herein as contemplated by the foregoing Resolution be, and are hereby adopted, affirmed, approved and ratified in all respects as the act of the MSPA.

THEREFORE, BE IT RESOLVED BY THE **BOARD** OF COMMISSIONERS OF THE MISSISSIPPI STATE PORT AUTHORITY AT **GULFPORT, AS FOLLOWS:**

The Board of Commissioners hereby authorizes and directs the MSPA, by and through its Executive Director and/or his designee, to pursue and apply for certain Grant Funds that the MSPA is eligible to receive, including, without limitation, GCRF Funds, and to execute, complete and deliver all necessary documentation, applications and other instruments to the appropriate authority administering such grant(s), as may be required at any time and from time-to-time, based upon each Grant's requirements and to do and perform such other acts and deeds on behalf of the MSPA as may be deemed necessary or desirable at any time or from time-to-time in connection with the receipt of Grant Funds, which will be used for the advancement, promotion and development of the State Port, including, without limitation, projects that will impact the competitiveness of State Port and have the potential to generate increased economic activity at the State Port and throughout the Mississippi Gulf Coast region.

RESOLUTION NO. 22-02

After proper notice, a quorum of the Board of Commissioners ("Board") of the Mississippi State Port Authority at Gulfport ("MSPA") took up for consideration the matter of authorizing the MSPA to allocate and expend 20% matching funds for the exclusive use of eligible projects being pursued and applied for by the MSPA under the Mississippi Gulf Coast Restoration Funds ("GCRF") Grant Program for the purpose of making certain improvements to facilities at the State Port. Commissioner kester moved for the adoption of the following resolution:

RESOLUTION OF THE BOARD OF THE MSPA AUTHORIZING THE MSPA TO ALLOCATE AND EXPEND 20% MATCHING FUNDS FOR THE EXCLUSIVE USE OF ELIGIBLE PROJECTS BEING PURSUED AND APPLIED FOR BY THE MSPA UNDER THE MISSISSIPPI GULF COAST RESTORATION FUNDS GRANT PROGRAM, WHICH WILL BE USED FOR CERTAIN IMPROVEMENTS AT THE STATE PORT.

WHEREAS, Section 59-5-37(1) of the Mississippi Code authorizes, among other things, the MSPA to make all contracts and purchases incidental to or necessary for the advancement, promotion and development of the State Port;

WHEREAS, in a manner consistent with the authority granted under Section 59-5-37(1) of the Mississippi Code, the MSPA is eligible to pursue and apply for certain grant funds that will be used for the advancement, development and improvement of facilities at the State Port;

WHEREAS, the Board of Commissioners has authorized, by separate resolution, the MSPA to pursue and apply for GCRF Grant Funds for certain improvements at the State Port, including, without limitation, the planning and preliminary design of a cold storage and blast freezer facility and a study to determine: (1) the most advantageous location for such a facility, and (2) the utility upgrades that would be necessary for such a facility (the "Cold Storage Project");

WHEREAS, the Cold Storage Project will create additional sources of revenue for the State Port and the increased capacity for such operations will stimulate economic growth and development at the State Port and throughout the Mississippi Gulf Coast region;

WHEREAS, the MSPA hereby accepts the Opinion of Probable Cost for a cold storage facility, dated _____, prepared by James Buras, showing an estimated cost of \$2,500,000.00 for the planning and feasibility study and preliminary design of the facility, a copy of the estimate is attached hereto as Exhibit "A" and fully incorporated herein by this reference;

WHEREAS, in conjunction with the pursuit of such GCRF Grant Funds, the Board of Commissioners of the MSPA hereby authorizes the MSPA to allocate and expend 20% matching funds for the exclusive use of the Cold Storage Project based upon the preliminary cost estimate referenced hereinabove, which amount of said matching funds is currently estimated to be \$500,000.00, which matching funds may be increased based upon the MSPA's receipt of final design plans and total project costs;

WHEREAS, the source of the MSPA's matching funds for the Cold Storage Project shall be from the MSPA's operating account, which the entire balance of the matching funds have been

presently secured and shall remain as readily available funds exclusively earmarked for the Cold Storage Project in said account until such time as a final eligibility determination for such Project is made and in the event the MSPA is not awarded the GCRF Grant Funds, the matching funds shall be released from its exclusive earmark for the Cold Storage Project without further action by the Board of Commissioners;

WHEREAS, in accordance with Section 59-5-37(1) of the Mississippi Code and in the event the MSPA is awarded GCRF Grant Funds for the purposes stated herein, the Board of Commissioners hereby finds that the allocation and expenditure of 20% matching funds for the exclusive use of the Cold Storage Project is incidental to or necessary for the advancement, promotion and development of the State Port and creates additional sources of revenue for the State Port and increases the capacity for such operations that be designed to stimulate economic growth and development at the State Port and throughout the Mississippi Gulf Coast region;

WHEREAS, the Board of Commissioners hereby authorizes and directs the MSPA, by and through its Executive Director and/or his designee, to allocate and expend the 20% matching funds currently estimated to be in the amount of \$500,000.00, which amount may be increased based upon the MSPA's receipt of final design plans and total project costs, for the exclusive use of the Cold Storage Project, and to execute, complete and deliver all necessary documentation, applications and other instruments to the appropriate authority administering such grant(s), as may be required at any time and from time-to-time, based upon the GCRF Grant requirements and to do and perform such other acts and deeds on behalf of the MSPA as may be deemed necessary or desirable at any time or from time-to-time in connection with the matters contemplated in this Resolution; and

WHEREAS, that, any and all actions heretofore or hereafter taken by the Executive Director and/or his designee in the name and on behalf of the MSPA in connection with or related to the matters set forth herein as contemplated by the foregoing Resolution be, and are hereby adopted, affirmed, approved and ratified in all respects as the act of the MSPA.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE MISSISSIPPI STATE PORT AUTHORITY AT GULFPORT, AS FOLLOWS:

The Board of Commissioners hereby authorizes and directs the MSPA, by and through its Executive Director and/or his designee, to allocate and expend from the MSPA's operating account the 20% matching funds currently estimated to be in the amount of \$500,000.00, which amount may be increased based upon the MSPA's receipt of final design plans and total project costs, for the exclusive use of the Cold Storage Project, and to execute, complete and deliver all necessary documentation, applications and other instruments to the appropriate authority administering such grant(s), as may be required at any time and from time-to-time, based upon the GCRF Grant requirements and to do and perform such other acts and deeds on behalf of the MSPA as may be deemed necessary or desirable at any time or from time-to-time in connection with the matters contemplated in this Resolution.
